It is expressly stated that the packaging complies with all applicable, relevant provisions of the following EU regulation:

REGULATION (EU) 2025/40 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 19 December 2024 on packaging and packaging waste, amending Regulation (EU) 2019/1020 and Directive (EU) 2019/904 and repealing Directive 94/62/EC and transposing it into national law of the Federal Republic of Germany VerpackDG (Packaging Law Implementation Act)

In particular, the packaging complies with the requirements in force and applicable from 12.08.2026 in accordance with Articles 5 to 12 of the Regulation:

### ARTICLE

- #5 No PFAS, no heavy metals from the paper or film production process
- #6 52% recyclable. The paper and the sealing layer are both compostable.
- #7 The paper is 100% recycled FSC, so the entire composite is made of 60% PCR.
- #8 Both the paper and the sealing layer are largely bio-based.
- #9 The material is based on the testing requirements of compostable packaging.
- #10 The material content of the packaging is 7% of the volume (200 x 200mm for inflated cushions).
- #11 The air cushions made of PaperWave can be reused several times.
- #12 The air cushions made of PaperWave carry all the relevant labelling requirements.

This statement does not constitute a confirmation of conformity with future requirements or future application dates of the PPWR. The conformity assessment procedure was carried out in accordance with Annex VII Module A. The conformity assessment is based on internal audits, as well as the information and evidence provided to us by our raw material suppliers and testing laboratories.
