It is expressly stated that the packaging complies with all applicable, relevant provisions of the following EU Regulation:

REGULATION (EU) 2025/40 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of December 19, 2024, on packaging and packaging waste, amending Regulation (EU) 2019/1020 and Directive (EU) 2019/904, and repealing Directive 94/62/EC, as well as its transposition into the national law of the Federal Republic of Germany as the VerpackDG (Packaging Law Implementation Act)

In particular, the packaging complies with the requirements set forth in Articles 5 through 12 of the Regulation, which will take effect and become applicable as of August 12, 2026:

ARTICLE

- #5 No PFAS, no heavy metals from the film manufacturing process
- #6 The film is certified as recyclable
- #7 The post-consumer recycled (PCR) content is >80%, usually 90%
- #8 Bio-based content (not applicable to PCR-based film)
- #9 Compostable (not applicable to LDPE)
- #10 The packaging material accounts for less than 5% of the volume
(for inflated cushions measuring 200 x 200 mm)
- #11 Air cushions made from ClimaFilm-100 are reusable
- #12 The air cushions made of ClimaFilm-100 bear all relevant labelling requirements

This declaration does not constitute a confirmation of conformity with future requirements or future dates of application of the PPWR. The conformity assessment procedure was conducted in accordance with Annex VII, Module A. The conformity assessment is based on internal tests, as well as the information and evidence provided to us by our raw material suppliers and testing laboratories.
