It is expressly stated that the packaging complies with all applicable, relevant provisions of the following EU regulation:

REGULATION (EU) 2025/400 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 19 December 2024 on packaging and packaging waste, amending Regulation (EU) 2019/1020 and Directive (EU) 2019/904 and repealing Directive 94/62/EC and transposing it into national law of the Federal Republic of Germany VerpackDG (Packaging Law Implementation Act)

In particular, the packaging complies with the requirements in force and applicable from 12.08.2026 in accordance with Articles 5 to 12 of the Regulation:

ARTICLE

- #5 No PFAS, no heavy metals from the film production process
- #6 The film is certified recyclable
- #7 The recycled content is currently 52% as a mix of PCR and IR
- #8 Bio-based content (not applicable to HDPE-based film)
- #9 Compostable (not applicable to HDPE-based film)
- #10 The material content of the packaging is less than 5% of the volume (for inflated cushions 200 x 200mm)
- #11 The air cushions made of ClimaFilm-50 can be used several times
- #12 The air cushions made of ClimaFilm-50 bear all the relevant labelling requirements

This statement does not constitute a confirmation of conformity with future requirements or future application dates of the PPWR. The conformity assessment procedure was carried out in accordance with Annex VII Module A. The conformity assessment is based on internal audits, as well as the information and evidence provided to us by our raw material suppliers and testing laboratories.
